

PRIVACY POLICY

This Privacy Policy describes how LLC Relocate (hereinafter referred to as "the Company", "we", "us", or "our"), acting as a data controller, collects, processes, and protects personal data of users (hereinafter referred to as "the User", "you", or "your") visiting our website relocate.ge (hereinafter referred to as "the Website").

Our data processing practices are in strict compliance with the Law of Georgia "On Personal Data Protection" and international data protection standards.

1. Data Controller Information

2. What Personal Data We Collect

We collect only the minimum necessary information required to process your B2B inquiries:

- Identity Data: Full name, company name, corporate position.
- Contact Data: Phone number, corporate email address.
- Technical Data: IP address, browser type, location information, and cookies (via analytics tools like Google Analytics).

3. Purpose and Legal Basis for Data Processing

According to Georgian law, we process your personal data based on your explicit consent, for the performance of a contract, or to take pre-contractual steps at your request. The purposes include:

- To process your inquiries and requests submitted via website forms.
- To estimate cost, budget, and plan corporate or industrial relocation services.
- To communicate with you regarding your commercial inquiries.
- To improve technical performance and user experience during relocation planning.

4. Data Retention Period

We store your personal data only as long as necessary to fulfill the purposes for which it was collected, or to comply with statutory legal and accounting obligations in Georgia. Once the purpose is achieved, the data will be securely deleted.

5. Third-Party Disclosures

We do not sell, rent, or trade your personal data to third parties. We may disclose your information to trusted third-party service providers (such as subcontractors, IT hosting, CRM systems, or analytics providers) who assist us in operating our relocation services, provided they maintain strict confidentiality.

6. Data Security

We implement appropriate technical and organizational security measures to protect your personal data against unauthorized access, alteration, accidental loss, disclosure, or destruction.

7. Your Rights Under Georgian Law

As a data subject under the Law of Georgia "On Personal Data Protection", you have the right to:

- Request information regarding which of your personal data we process and how it was obtained.
- Demand the correction, update, or rectification of inaccurate data.
- Demand the suspension, erasure, or destruction of your personal data.
- Withdraw your consent to data processing at any time.
